Box 70973 Rochester Hills, MI 48307	Ann Erickson Gault is running for Oakland County Commissioner in the 11th District representing Troy, Rochester Hills, and Auburn Hills. She an attorney, small business owner, Past President of the Women Lawyer Association of Michigan, and a homeowners' association board member. She lives Troy with her husband Tom and their daughter Ellie who will be an Athens High School student in the fall. In 2017, Ann Erickson Gault led a team of volunteer petition circulators from Troy and Rochester Hills for the nonpartisan group Voters Not Politicians. Her team collected more than 4000 signatures to help put an independent redistricting proposal on the ballot in November. Ms. Erickson Gault plans to bring new leadership to County government and create an Oakland County that works for all of us. Her background as an advocate will allow her to vigorously represent the needs of her constituents, while her skills as a negotiator and leader will allow her to reach consensus on difficult issues.	Oakland County's suffers from crumbling roads and failing infrastructure. The County budget is \$900 million, yet we spend less than 1% of that on roads. As a County Commissioner, Ann Erickson Gault will fight to increase road spending and ensure safe drinking water. Another issue in Oakland County is the lack of affordable housing. A recent study found that a person earning minimum wage could not afford a studio apartment in Oakland County. As County Commissioner, Ann Erickson Gault will promote development of affordable housing for working people, seniors, and our vulnerable populations. Oakland County also lacks the vision to create the economy and job market of the future. At my daughter's Eighth Grade promotion ceremony, a speaker noted that many of the students of the class of 2022 will work at jobs that we haven't even imagined yet. As County Commissioner, Ann Erickson Gault will ensure that our economic development promotes the businesses and jobs of the future.
