## THE 21<sup>ST</sup> CENTURY VOTER: PROMOTING MICHIGAN VOTER POWER

This conference on election reform issues will be held on **Friday, April 24<sup>th</sup> at Henry Ford Community College** (HFCC), 5101 Evergreen Rd. in Dearborn from **9 am to 3:30 pm**. LWV of Michigan and HFCC are the lead sponsors of the event.

The forum covers several **topics on the State League's Democracy Agenda** which our League designated as high priorities.

- **Term Limits**
- **Making Voting Easier for Voters**
- **Fair and Impartial Courts**

Senate Majority Leader Mike Bishop of Rochester and House Speaker Andy Dillon of Redford will participate on a panel with two university professors to specifically address the issue of Term Limits and their effects and proposals for constitutional change.

The opening address will discuss innovations in state election laws and will be followed later by a panel of county and municipal clerks, including Novi's Clerk Marian Cornelius, providing perspectives on enacting and implementing alternatives such as no-excuse absentee voting, early voting, and voter registration reforms.

Chief Justice Marilyn Kelly will be the luncheon speaker and address the effects of money and politics in campaigns for the Michigan Supreme Court and how to safeguard public confidence in the court's impartiality. A panel of leaders of key interest groups will later discuss the role of candidate-focused issue advertisements in those campaigns.

## NATIONAL POPULAR VOTE COMPACT

Thank you to **Barbara Suhay** for providing an informative and concise overview of the National Popular Vote (NPV) Compact for our Consensus meeting on the topic. She provided copies of the Constitution and pointed out that two sections of the U.S. Constitution relate to this reform which proposes a mechanism to achieve a national popular vote without passing an Amendment to the Constitution to abolish the Electoral College.

Article II, Section 1, paragraphs 2 and 3 discuss the appointment of electors by each state's legislature for its state. Maine and Nebraska use the district plan where whoever wins each congressional district gets that elector and whoever wins the state gets 2 votes. All other states are winner-take-all of the state's electoral votes. Proponents of the NPV Compact argue that, because states specify how electors are chosen, each state can specify that the national popular vote winner receives all its electoral votes.

Article I, Section 10, paragraph 3 says that "No State shall, without the Consent of Congress, ..., enter into any Agreement or Compact with another State, .... Opponents of the NPV compact argue that Congressional approval of the NPV Compact is required and would be difficult to achieve while proponents cite cases where Congressional approval for a compact was not required such as on state boundary lines.

Other issues discussed included recounts, enforcement of the compact, impact of minor parties, and ballot wording related to selecting electors. Our League's Consensus on the seven questions dealing with the NPV Compact will be submitted to LWVUS for consolidation with other Leagues in the U.S. and the National Board will then determine if there is a national consensus on the NPV Compact.

## MAY 5, 2009, ELECTIONS

Each year more school districts move their elections from the spring to November. In 2009, Oakland County school districts that will hold an election of board members on May 5<sup>th</sup> are: Clarenceville, Clarkston, Clawson, Ferndale, Hazel Park, Lake Orion, Lamphere and Oak Park. West Bloomfield Schools has a technology and school improvement bond proposal.

Bloomfield Hills is the only city with an election which includes both City Commissioners and a library millage. The cities of Clawson and Novi have proposals on the ballot for a Library Bond and a Parks & Recreation millage, respectively.

There are only three contested elections and LWVOA is doing candidate forums for each of them.

## **COME to the STATE CONVENTION of the LWV of Michigan!**

Would you like to meet and work with other League members from across the state, ask questions, pursue common interests, participate in workshops, learn more about the League, and get great information to use here in Oakland County?? **Come to the Michigan State Convention whose theme is "The League of Women Voters in the 21<sup>st</sup> Century"!**

The 31<sup>th</sup> biennial **State Convention** of the League of Women Voters of Michigan will be held **May 15-17, 2009**, at the Sheraton **Lansing** Hotel. Delegates from 24 Local Leagues throughout Michigan will meet to adopt the state program and a budget for the next two years, amend bylaws and elect a board of directors. As the largest League in the state, Oakland Area is entitled to 11 delegates.

**Activities run from Friday afternoon through noon on Sunday.** There are three plenary sessions (Define, Discuss, Decide) dealing with the business of the convention. Workshops will include topics

such as League program, voter service, communication, membership, financing, and staying relevant in a changing world. The **Saturday evening speaker will be Secretary of State Terri Lynn Land.**

The cost per person including two nights with a shared room, meals, and registration fee is \$236. \$125 of that covers registration, which includes three meals on Saturday plus Sunday breakfast. LWVOA will cover the \$125 registration, but not the room cost which is \$111 if you share.

The 2008 Michigan Supreme Court election campaign was the most expensive yet for a single seat on the Court, and one of the most rancorous in memory. Over half the money spent in the campaign paid for candidate-focused issue advertisements, for which there is no real financial accountability. This decade-long pattern raises questions of recusal and due process that can undermine faith in the impartiality of Court decisions. How can we conduct campaigns that don't impede First Amendment rights, and don't undermine trust and confidence in the impartiality of the Michigan Supreme Court?
