## **We Count! - 2010 Census** **Public Service Announcement Contest**



LWV Oakland Area is sponsoring a **contest for Oakland County high school students to write a Public Service Announcement (PSA) for the 2010 Census**. The contest is open to public, private, parochial and home-schooled students who reside in or attend class in Oakland County. The contest theme is the importance of participating in the 2010 Census. Students will create PSAs targeted at residents reminding them to fill out the census form and return it to the Census Bureau.

**Contest categories are Radio, Television and Print media.** The winning entry in each category will receive a \$250 cash prize. Entries will be judged on creativity, originality, clarity, motivational message and use of theme. Entries must be mailed by January 20, 2010, and received by January 30. Judging will occur in February and an award reception will be held in late February to announce the winners and recognize all contestants. The winning entry from each category will run on local television and radio stations and be published in local newspapers in March and April.

**Information on entering the PSA contest can be found at the LWVOA web site at [www.lwvoa.org](http://www.lwvoa.org).** It is also available on the Oakland Schools website [www.oakland.k12.mi.us](http://www.oakland.k12.mi.us) under Departments/Learning Services/Humanities and selecting Social Studies. Contest details and census information, the submission form and a release form are provided.

In mid-March 2010, every residence will get just the short form with the basic demographic questions. No one will receive a long survey form. **The results of the 2010 Census** will affect the dispersion of federal and state funds for many programs as well as representation in Congress and redistricting of the state legislature and county commission. Public infrastructure and private investment are impacted too.

### **Census ALERT for Snowbirds who may be out of Michigan on April 1:**

If you consider Michigan your primary residence, **do NOT fill out any Census form you receive in the other state where you are wintering even if you are there on April 1**, the official census count date. Wait until you return home to fill out the form received at your Michigan residence. If no form is returned from your home address, Census Workers will be following up by knocking on doors in May to collect the information, giving you an additional chance to complete the Census information. **This is critical to funding of programs and representation for Michigan.**

## Health Care Reform – Let's Get Real!

In answer to an audience question about the debate on health care reform, Dr. Vic Velanovich, who spoke on outcomes research and its benefits for health care reform, said that **the U.S. has not decided whether health care should be a "Commodity" or a "Public Good"**. That answer captures the essence of the debate waging in Washington. Dr. Leonard Fleck, who spoke on ethics as applied to health care reform, picked up on that and said that the answer in most cases should be the public good, but that in marginally beneficial cases, treating as a commodity made sense.

A full audience of non-members and League members listened attentively to the insightful presentations that addressed the realities of health care today and what is necessary to improve it and keep costs under control. How should care decisions be made and who should make them were thoughtfully discussed. Today, by deciding what care they will pay for, the insurance companies effectively make many of the decisions.

**Dr. Velanovich** discussed the cycle of medical progress and the obstacles which result from differing objectives of the stakeholders:

Patients – Wants to live longer, live better and do so with as little "out of pocket" expense as possible.

Doctors – Want patients to do well and want to make a living.

Hospitals – Want to survive, have their patients do well, improve market share and serve their communities.

Medical-Industrial Complex – Wants to maximize profits and shareholder value while limiting legal exposure.

Insurers – Want to maximize profits, improve market share, minimize costs and avoid regulation.

**Outcomes research** analyzes the results of episodes of care to better understand how different procedures, operations, devices or drugs impact health status. Doctors want to do the right thing, but frequently may not know what is best. Patients want to get well, but frequently the choice of treatments is not clear. Payers want the most value (=Quality/Cost) for the money spent, but frequently information is poor or non-existent.

**Comparative Effectiveness Research (CER)** helps doctors and patients choose the treatment option that best fits the patient needs and preferences. The American Recovery and Reinvestment Act (ARRA) provided funds for CER and established a Federal Coordinating Council for CER.

Dr. Velanovich believes that there has to be a better reason to institute a treatment plan than "just because." We need to recognize knowledge is incomplete and where the deficiencies are. We need to understand patients and what is important in their lives. We need to use that knowledge to discuss effective treatment options with a reasonable predictive outcome. We should not have to consider who makes money or whose political dogma is offended. He supports Comparative Effectiveness Research as essential to better quality health care while controlling costs.

**Dr. Fleck** discussed what is needed for a just and caring society. He argued that health care reform is essential because the current system is unjust in basic respects, because it often prevents physicians from providing needed care to their patients, and because it forces physicians to be agents of injustice. He discussed injustices such as ability to pay, using large amounts of funding for slight health gains when lots of unmet health needs could be met effectively at lesser cost, allowing incentives and cost controls to determine tests and other health resources for patients, etc.

In 2008, the U.S. spent \$2.5 trillion on health care or 16.5% of GDP. In 1960, it was just 5.2% of GDP. It is projected to be 20% of GDP in 2018. Most European nations and Canada spend 8-10% of GDP. 35% of U.S. expenditures go for those over age 65 – 13% of the population and growing. Health Costs are increasing for many reasons, including medical technology, chronic illnesses, last chance therapies, administrative costs, etc.

Dr. Fleck stated that, while rationing is inescapable, it is not intrinsically morally objectionable. A just health care system with rationing must be public, visible, publicly legitimated, and self-imposed. He argues that through rational democratic deliberation we can collectively, fairly and impartially identify and impose fair rationing protocols. What is fair for a stranger with a specific condition should be fair for you, too, if you have that condition. An example: No Implantable Cardiac Defibrillator for an end-stage Alzheimer's Disease patient.

In the Q&A, both men agreed that too often those who fund legislators control the laws. Both men believe doctors and patients together should decide the appropriate health care for each individual, not hospitals or insurance companies. Payment based on outcomes, rather than fees for specific services, will improve quality.

A major **THANK YOU to Dr. Renate Soulen** who arranged the program and the excellent speakers. LWVOA received kudos from many members of the audience. President **Judy Bateman** moderated the meeting. Judy and Renate also provided delicious nibbles and coffee. The program was recorded for rebroadcast.

To celebrate the League's 90<sup>th</sup> anniversary, **LWV of Michigan** is planning an Advocacy Day in Lansing in early Spring of 2010 with lunch, education on Michigan issues (especially regarding voting) and how to advocate for them with follow-up meetings with your legislators. Stay tuned for more details. The State Board recently voted to support the concept of early voting in Michigan. We also support no-excuse absentee ballots. The state League is also active in the Public Advocacy for Voter Protection (PAVP) project to simplify voter registration with Oakland Area actively involved.

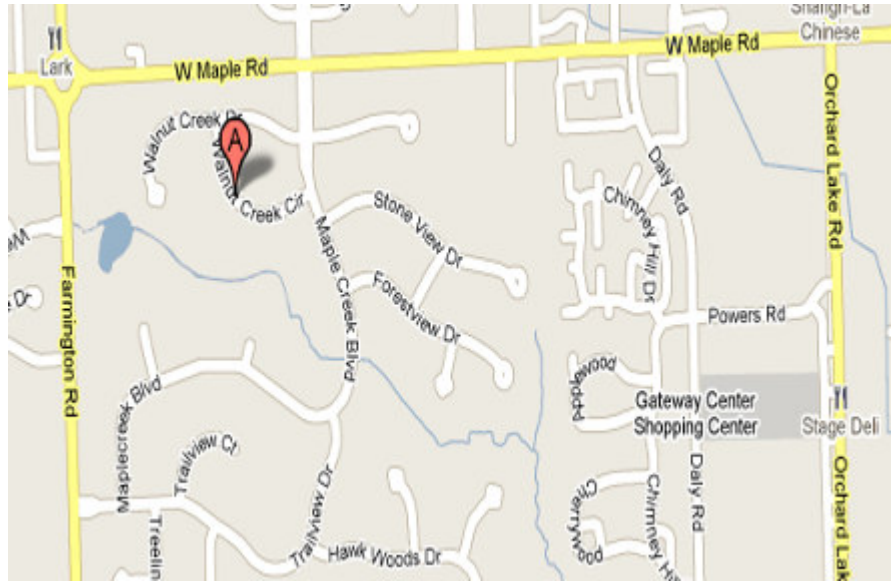

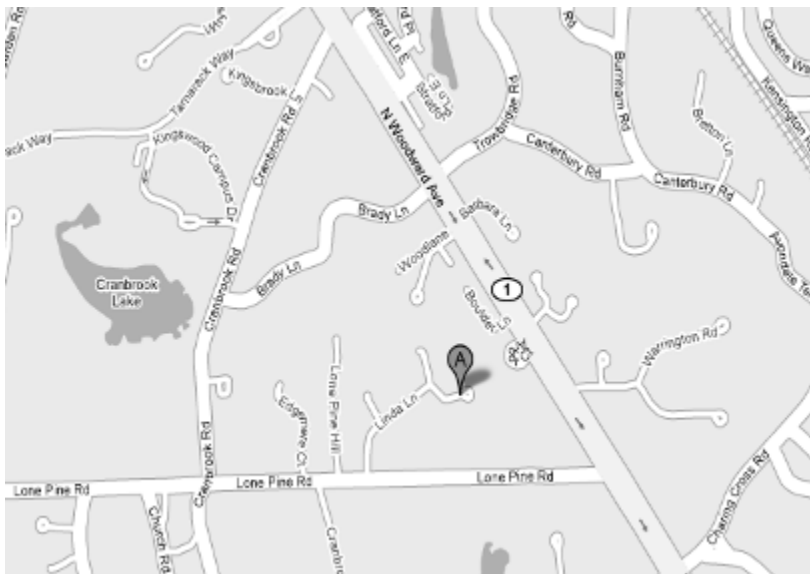
