## PRESIDENT'S MESSAGE

2011 concluded with one last challenge for our Voter Service people who were completing 19 candidate forums in Oakland County. Mary Bugeia of DMA had received a last minute request to do one in Warren for the city election. Mary contacted us and together the Dearborn-Dearborn Heights League and LWVOA accepted the challenge and put one together which was well received by the participants and those who attended.

Coming up in February is our fund-raising movie social at Renate Soulen's home. (See page 1.) After that, study and consensus will occupy us for the first half of 2012.

A national **study on Privatization** is scheduled for March and April with consensus due by May 1. This timely study will consider the transfer of services, assets and functions to the private sector, community impact, and strategies to ensure transparency and accountability. The study is being chaired by Jeff Jenks. If you would like to join the study, contact Jeff at [travelisfun@wowway.com](mailto:travelisfun@wowway.com).

A State League **study on Redistricting** is also in the works. It will include a brief history of redistricting in Michigan; the problems with the redistricting process, and an overview and evaluation of procedures used by other states. Consensus questions and background information will be sent to local Leagues with consensus to be completed by June 1.

This study should be especially timely since Redistricting in Oakland County is still in the news with the controversial passage of a bill that will shrink the number of County Commissioners from 25 to 21 and allow the commission members to carve out voting districts. Until passage of this bill, districts were drawn by the five-member Apportionment Commission, made up of the County Clerk, Treasurer and Prosecutor, as well as the Chairs of the county's Democratic and Republican party committees. This year, it is 3-2 majority Democratic. The Board of Commissioners is majority Republican and the Democrats have called the measure politically motivated and plan to challenge it as against the state Constitution.

The State League has been busy. In the area of advocacy, they are fighting obstacles to voting, including State Election bills SB751 and SB754 that create unnecessary barriers to voting. Even though there is no evidence of fraud in Michigan elections, the bills would require photo ID to obtain absentee ballots and require state certification and training of third party agencies doing mail-in registration which will make it more difficult for League members to register people to vote.

On top of that, the LWVMI office moved to 600 W. St Joseph Street, Lansing, MI 48933. The phone number 517.484.5383 will remain the same. This move was necessitated by the Impressions 5 Museum's building renovation taking over the League's office space.

**R**ole of Federal Government in Public Education, a national study, was completed and consensus taken due to the diligence of education committee members - Mary Ann Barkach, Grace Kachaturoff, Kathleen Maisner, Geri Rinschler, Barbara Rosalik and Lori Soifer.

The first of two general meetings covered **Common Core Standards** - educational standards developed by the states and adopted by all but two states. **Dr. Michael Yocum**, the Director of Learning Services at Oakland Schools, along with Panel Chair **Geri Rinschler** and **Lori Soifer**, both Birmingham School Board trustees and League members, explained what Oakland County is doing to develop a high quality curriculum and to train teachers. In the past tests relied on multiple choice questions. Now the focus in teaching and testing will be on critical thinking and writing in which a reasonable argument should be made to advance an idea. This will be an enormous job requiring a multi-year effort at a time when less funds are available.

Our second general meeting covered **Equity and Funding**, and we were fortunate to have State School Board Member **Dr. Casandra E. Ulbrich** speak, along with **Geri Rinschler**, Panel Chair. They described how under the Bush administration and **No Child Left Behind** legislation, the emphasis was on accountability as measured in test scores and set 2014 as the year in which all students were to be 100% proficient in math and reading. Schools were measured on AYP (Annual Yearly Progress) goals, and thousands of schools failed. In August, 2011, Pres. Obama's Secretary of Education Arne Duncan reversed direction of the law and urged states to apply for waivers if they were carrying out serious school improvement programs.

Pres. Obama emphasized competition, and urged states to apply for **Race to the Top Funding (RTTT)**. The problem with this was that states had only two months to apply. In the first round, only two states got RTTT funding – Michigan not included. Now Michigan has the reforms, but not the funding. Our panelists both believe that the Dept. of Education should be non-partisan.

In discussing these issues and reaching consensus, LWVOA members rejected the over-emphasis on testing in recent years and believed teaching should emphasize knowledge, skills and reflective thinking. Use of the word “mandates” was rejected, preferring government “support”. Already approved mandates and any new programs should be fully funded. They felt a combination of competitive and non-competitive grants are acceptable, if the states are given sufficient time to apply. Implementation of Common Core Standards should be voluntary, not mandatory, with the federal government assuming the supporting role in the development of curriculum. The schools primary responsibility is to provide the best teaching/learning environment for ALL students. While not part of the consensus, many members expressed concern that public education is slowly being dismantled by entrepreneurs and groups with their own agendas, making education a profitable venture. Funding for public education is diminishing as “reform” institutions are established.



### Coming up – Privatization Study by Mary Ann Barkach

Our work is never done. Next up is the national **Privatization Study**. The scope of the study “is to identify those parameters and policy issues to be considered in connection with proposals to transfer federal, state or local government services, assets and/or functions to the private sector. It will review the stated goals and the community impact of such transfers, and identify strategies to ensure transparency, accountability, and preservation of the common good.” **To participate in this timely study, contact Jeff Jenks**, Chairman, at [travelisfun@wowway.com](mailto:travelisfun@wowway.com). A Michigan example of privatization dilemmas is occurring in Grand Rapids where the State wants to dismiss 170 nursing assistants at \$20/hr. on the public payroll and replace them with contract workers at \$10 /hr. at a 125 year old veterans' home serving nearly 600 residents. The plan has resulted in a lawsuit contending that patient care is being jeopardized. ## Candidate Forum Report Fall 2011 by Judy Bateman

This election season LWV Oakland Area was involved in **20 candidate forums** from the primary in August through the November general election. The forums were well attended and many were covered in the media. We were even served coffee and cookies at a few forums. Eighteen forums were **coordinated by Jerry Burden, Judy Bateman, and Ann Edwards**. City forums hosted included Southfield (primary and general), Clawson, Keego Harbor, Sylvan Lake, Pleasant Ridge, Royal Oak, Rochester Hills (primary and general), Ferndale, Rochester, Birmingham, and Lathrup Village. School board forums hosted covered the Huron Valley, Birmingham, Rochester, West Bloomfield, and Berkley districts. The Council of Homeowner Associations in Farmington Hills coordinated a city forum which we co-sponsored and Mary Ann Barkach participated as a questioner on the panel. We also teamed with LWV of Detroit Metro Area to hold a forum for Warren in Macomb County for their city election.

### Interviewing City and County Clerks by Mary Ann Barkach

LWV members fanned out in November-December to interview city and county clerks. Results of the study and recommendations for changes to policy or practices will be distributed to and discussed with clerk associations and the Secretary of States Bureau of Elections staff. The survey is a national LWVEF Public Advocacy for Voter Protection project which the LWV of Michigan is participating in.

Here in Oakland County, city/township clerks were interviewed by **Mary Howarth and Ann Edwards** in **Rochester Hills**, **Renate Soulen** in **Bloomfield Township**, and **Gretchen Pugsley and Doug DePoorter** in **Novi**. The purpose was to collect information about how local clerks recruit and train election workers, and what election-day problems they encounter. Our members found the interviews to be informative, and they were impressed with the availability and cooperativeness of the clerks.

County Clerk Bill Bullard and Election Director Joe Rozell were interviewed by **Sheryl Mitchell and Eva Packard**. Oakland County provides poll worker training for communities with less than 10,000 population. Communities with more than 10,000 population do their own election training or they can go to the County for training. Poll workers who miss the local training session also can attend the county training.

Oakland County faced an unusual challenge when Pontiac's Emergency Manager fired the City Clerk shortly before the November 8<sup>th</sup> election, and the County had to assist in administering the election. Having sufficient poll workers proved to be a challenge, and the County helped the city work around the shortages due to poll workers who resigned or did not show up by recruiting a few from townships with no elections, by merging separate precincts in a location and by sending a few County workers to help. Fortunately, only a State Rep vacancy and an uncontested school board election were on the ballot so turnout was light.

### Italian American Club election

The Italian American Club in Livonia again asked the LWVOA to conduct their election on October 19<sup>th</sup> from 11:30 am until 7:00 pm. **Linda DePoorter** chaired the project assisted by her husband, **Doug DePoorter, Betty Spehar, Gretchen Pugsley, Jan Dolan, and Mary Ann Barkach**. Linda organized the election in a very professional manner and taking part was enjoyable. Nevertheless, it proved challenging because the vote was very close requiring a recount. Kay Pugsley joined us for the recount. This effort is also a fundraiser, and LWVOA was paid well for our effort.

# HUMAN TRAFFICKING

**Dr. Nicole McGee, Victims Specialist at the FBI**, addressed the Fall Luncheon on October, 17, 2011, on the topic of Human Trafficking, the illegal trade of human beings for the purposes of reproductive slavery, commercial sexual exploitation, forced labor, or a modern-day form of slavery. The Detroit office covers all of Michigan and McGee handles the Victims Assistance Program for Southeast Michigan.

Southeast Michigan is a major hub for recruitment of young people who are enticed or coerced into the prostitution business. Many come from the suburbs and are susceptible to running away. Social media helps the recruiters find kids, providing names, photos, interests, high school, and a sense of the child's self-esteem. They are 'befriended' either online, or at their school or at a mall. The average age is 13 and they are often sent to major cities in other states so that they are isolated and know no one. They are introduced to drugs which make them dependent. Pimps also threaten that the kids' families will be hurt. Victims have a life expectancy of 7 years as beatings and overdoses are common. 300,000 kids go missing each year. Children 11-16 and missing over 48 hours are likely victims of child prostitution.

This trade is now done mostly online, not on the street. Pimps target clients at major sports events, truck stops, massage parlors, casinos, apartment complexes, etc. and use escort services, social networking sites, and throwaway phones so not traceable.

The Southeast Michigan Child Victims Task Force (FBI, State Police, and various local police) investigates cases. Missing persons are entered into a national database with photo. Analysts go through websites looking for them, especially if underage escorts are offered. If a child is found, they are returned to stable parents or put into foster care, but they may run away again. Victims are not prosecuted. McGee urged everyone to be vigilant and aware. Contact the FBI if they suspect someone may be a victim. A sign of victimization could be an Asian worker in a restaurant or one doing nails who won't talk.

Thank you to **Dorothy Conrad and Marge Polidori** for again putting on a compelling program and a tasty lunch and donating the funds received to the Oakland Area League to support its activities. The event attracted not only League members, but also members of churches studying human trafficking.




