National Convention Highlights

Renate Soulen and I just got back from National Convention in Washington D.C. We dashed from caucuses - to workshops - to plenary sessions. It was a bit dizzying, but meeting Leaguers from all over the country is very energizing.

National Board and staff made a real effort to address our concerns, and one major concern is falling membership. National launched a new campaign to reverse this trend, and delegates enthusiastically voiced their support by donating a whopping \$35,000 on the spot to fund this initiative: Membership and Leadership Development.

You will be happy to learn that Convention adopted a concurrence with the Sentencing Policy position as follows: "The LWVUS believes alternatives to imprisonment should be explored and utilized, taking into consideration the circumstances and nature of the crime. The LWVUS opposes mandatory minimum sentences for drug offences."

The impact of money on our elections due to the *Citizens United* decision resulted in a resolution being passed calling upon the Board to "advocate strongly for all appropriate, duly-considered measures which may include, but are not limited to, a constitutional amendment and which are consistent with our current positions on campaign finance reform and individual liberties; allow Congress and the States to set reasonable regulations on campaign contributions and expenditures; and ensure that elections are determined by the voters."

A motion also passed to review and update the LWVUS agriculture position addressing issues such as genetic modification, consolidation in the food industry, money in the regulatory process, and the consumer's right to accurate and comprehensive food labeling.

We were treated to an outstanding group of speakers and panelists, many of whom urged the League to look closely at the steps needed to fix the broken campaign finance system and to press forward on behalf of all voters and for elections that are determined by the voters.

Annenberg Public Policy Center's Kathleen Hall Jamieson gave an impassioned speech urging us to insist on truthfulness in media advertising. Be sure to visit Annenberg's **FlackCheck.com** for a humorous approach to fact checking and to recognizing deceptive speech.

Attorney General Eric Holder said, "I urge you – regardless of the opposition you face – to stay true, and remain fiercely committed, to the principles that have always guided the League of Women Voters and that can ensure that the 21st will be another 'American century.'"

I could go on and on, but this this is enough convention business for now.

The goal of this initiative is to draw media attention to loopholes in campaign finance laws that allow special interests to sponsor election ads without having to disclose their financial supporters. PRESIDENT'S MESSAGE

Power the Vote was the theme of the 2012 National Convention. And committed we are to doing everything we can to provide information to all citizens and to register them to vote. September 26th has been designated as a day for the LWV to register voters all across the country.

HOWEVER, despite the efforts of Sue Smith, our State President, and others, new legal requirements that affect how we register voters have passed the state legislature. The state League has been fighting against this bill, SB754, since November and was able to get an amendment that gives us 30 days after the bill's July 1 effective date to comply. The bill now goes to Gov. Snyder for his signature, and Sue Smith has sent him a letter asking him to veto it.

The new requirements will not take effect until August 1, and until then we may register voters as we usually do.

Unless Gov. Snyder vetoes the bill, beginning August 1 no one may register voters unless that person: (1) has taken training that is consistent with the new standards that will be developed by the Secretary of State and (2) has registered with the state on forms to be provided by the Secretary of State. There are legal penalties for not following the new requirements.

The state League is in conversation with its lawyer regarding the legal impacts of the new legislation, including who will be held "responsible" by the Secretary of State for League members following the new requirements.

The legislation also requires photo ID for in-person voter registration and absentee voting.

The legislation passed is part of a nation-wide push to make it more difficult to register and vote, and also more difficult for third-party organizations like the LWV to register voters. The proponents of the legislation say they need to prevent fraud and voter impersonation. However Clerks who run our elections have attested that there is no evidence of voter impersonation in Michigan. Michigan has strong election laws to protect the integrity of our elections and establishes the identity of voters by means of the Qualified Voter File, the state's voter registration data base.

Stay tuned. No one ever said democracy was easy.

FLASH: July 3

Gov. Snyder has vetoed three bills in a package of Republican-sponsored election reforms.

The vetoed bills would have required people to affirm their U.S. citizenship and show a photo ID before they can get a ballot, and require people to get training before they can register voters. In both cases, the governor says, the measures would have created too much confusion about who can vote or register people to vote.

VOTER GUIDES for Primary races in Oakland County will be posted on our website, www.LWVOA.org by July 9th. The U.S. Senate, U.S. Congress and State Representative races are available now on www.Vote411.org. This website displays races applicable to the voting address entered by the viewer.

Specify Michigan in "On Your Ballot" box of Vote411. On the next screen on the right, enter your Address, Community, Zip in the Personalized Ballot. A map will appear with a list of your voting districts. Continue to next screen; select English and continue to U.S. Senate race; next to U.S. Representative; then State Representative. Clicking on individual candidate names takes you to their response below under Comparison. Candidates can be compared two at a time. Later in July, the Oakland County races will also be posted on Vote411.org so it has a complete ballot and the federal and state races applicable to Oakland County will be available via the OA website.

In addition to the partisan federal and state races on the ballot, there are also 6 County Officers, County Commissioners, and all 21 Townships with races and (with NO guides) Precinct Delegates. This election is an **OPEN PRIMARY** which means you pick the political party in the secrecy of the voting booth. However, **you must pick all your partisan races for one party or you invalidate your ballot**. The Primary is a key election for predominantly one-party Townships.

Next on the ballot are the Nonpartisan races, such as for Judges and for the Pontiac City Charter Commission. The county, city/township/village, and school district ballot proposals follow. In addition to the LWVOA voter guides for Judges, see www.ocba.org (Oakland County Bar Association) for candidate responses to an additional 29 questions. Also on that website: Videos of the 4 judicial candidate forums held.


PSA Awards Ceremony Celebrates Creativity

LWVOA Supports Local Proposals in August Primary

While the League of Women Voters never supports or opposes candidates for office, it does study issues and takes positions on them after membership consensus. The Oakland Area board has taken positions on two local ballot proposals on the August Primary ballot and Letters to the Editor are being sent. **LWVOA SUPPORTS** the following proposals:

- OAKLAND COUNTY PUBLIC TRANSPORTATION MILLAGE RENEWAL (based on the LWV Detroit Metropolitan Area position supporting a regional Transit System) If approved, this proposal will renew the 0.59 mills levied in 2010-11, for the years 2012 through 2013, and will allow continued support to the Suburban Mobility Authority for Regional Transportation (SMART) for a public transportation system serving the elderly, disabled, and general public of Oakland County.
- Waterford Township Library millage renewal (based on LWVOA's position on support for local library services) The library is asking voters to renew its ten-year operating millage. The millage rate is 0.9118 per \$1,000 of taxable value, or \$44.57 per year for an average home in Waterford Township. As this is a renewal, there is no new cost for Waterford residents.
