The State League did take positions on three of the proposals (you can find these in full at www.LWVMI.org):

Proposal 12-1 A referendum on Public Act 4, the Emergency Manager Law - Vote "No"

Proposal 12-3 To amend the constitution to establish a standard for renewable energy - Vote "Yes"

Proposal 12-5 To amend the constitution to require a 2/3 majority vote to impose new or additional taxes - Vote "No"

Then there is the political advertising we have heard or received in the mail. A few of us are keeping track of this advertising for the Capture the Election campaign which the State League is handling.

To celebrate the end of this election cycle, LWVOA members are gathering for a post-election program. The details are on page 1. I hope you can join us for an easy and enjoyable evening.

Health Care Presentation Proves Hot Topic

The health care reform session we sponsored at the Bloomfield Township Public Library on Saturday, September 29, 2012 was a resounding success. **Marianne Udow-Phillips, MHSA**, Director of the Center for Healthcare Research & Transformation, a non-profit partnership between the University of Michigan and Blue Cross Blue Shield of Michigan, spoke on **Health Care in America – the Affordable Care Act and Other Solutions** to an enthusiastic audience of more than 70 people. Separating fact from fiction, she clarified this complex topic in a balanced thoughtful presentation which was followed by a lively question & answer period.

Leaguers Register Young Voters in Walled Lake

The core of the League of Women Voters spirit is to serve as a nonpartisan political organization, encouraging the informed and active participation of citizens in government. In honoring that mission, members of our Oakland County chapter spent the first week of October engaged in 'hands on' voter registration.

Ensuring that all eligible citizens are enabled to vote is honorable, and the actions conducted under this initiative were particularly valuable because they targeted the registration of those who are newly eligible or will soon be eligible to vote, the coveted "young voter". The goal: engage them early and have an active participant for life.

So earlier this autumn six League members: Mary Ann Barkach, Paula Creed, Carole Elder, Shelley Goldberg, Martha Martin, and Betty Spehar helped to register students at the Walled Lake Central and Walled Lake Northern high schools.

Two dozen students were 'walked through' the registration process and are now able to make sure 'their voices' will be counted on election day.

As Murphy's Law would dictate, the day was not flawless, and a few challenges were experienced. Remember those high school "tornado drills"? You guessed it, one took place in the middle of the registration process (SMILE). There also were a few logistical challenges, including a technical study program which resulted in some students being transferred off-site for the day.

However, the League of Women Voters members had a positive experience, interacting both with the students being registered to vote, as well as the teachers and principal at the school. A foundation was laid, interest has already been expressed in repeating the registration process in future years, and did I mention two dozen newly registered voters are now eligible to participate in the November 2012 elections?

The State Voter Guides



While we were working down here, Eva Packard, the state Voter Service Chair, was laboring to get the LWV of Michigan Voter Guide published. They also experienced record demand for their 95,000 copies. The 40-page Michigan Guide covered the presidential and other federal candidates, all statewide candidates, and the 6 ballot proposals along with the pros and cons.

We placed many LWVMI guides in Oakland County along with the LWVOA guides for students and others who live outside Oakland County.

In addition, Eva spent long hours uploading candidate information for 144 federal and state races into www.VOTE411.org, mentoring Local Leagues as they also used Vote411.org for their local area races, and downloading federal/state races needed by Local Leagues for their printed guides.

THE VOTER GUIDE TALE

A few weeks back, one of our members worried that all of our printed Voter Guides might not be used. A foolish concern indeed! In fact, by October 18, almost all of the 30,000 LWVOA voter guides were taken, and people were asking for more!

Deb Horner, mother of three and a full time employee at the University of Michigan, again found time to shepherd this project through to its conclusion. The Guide was 64 pages long – the longest ever – due in part to many school board elections now being held in November. With the Guide at the maximum page count for a printed guide, a decision was made to just list the wording of the six statewide ballot proposals and point readers to our website to get the pros and cons.

Deb along with helpers, Ann Edwards, Pat Szura, and Margaret Kanost, headed to the printer to proofread. Then the fun began. The printer was a few days late getting all the Guides delivered to libraries and city halls, and our office phone never stopped ringing. Patricia Finn went to the office one day to face 60 phone calls – mostly for Voter Guides but also for speakers and other election information.

Webmaster Tera Moon, a full-time librarian, who had been keeping our candidate forum schedule up to date, uploaded LWVOA Voter Guides. The Guides covered 200 local races and proposals, and were also linked to LWVMI's State Guide for 34 federal and state races relevant to Oakland County voters.

And let's not forget Ann Edwards, who also works, who mailed the Guides to our members and contributors, and Ann, Mary Howarth and others who distributed Guides to various colleges, offices, etc.

This was a major effort. But it is gratifying to know how people rely on our non-partisan voter information.

The full Oakland County printed Guide, and individual Voter Guides for each race in Oakland County, are available online at our website, www.LWVOA.org, as are Candidate Forum videos or cable times.

Gilda Jacobs Speech Highlights FALL LUNCHEON



On October 22, Dorothy Conrad and Marge Polidori once again put on their Fall Luncheon which raises funds for our League activities. It is always a special event giving members an opportunity to enjoy good food and good company before listening to a speaker.

Gilda Jacobs, President and CEO of the Michigan League for Public Policy, spoke on issues of gender and poverty, saying that Michigan has an uneven playing field. The gap between men and women's salaries is among the largest in the country at 23%. Women are more likely than men to live in poverty in every age group. In 2011, 2/3 of women with children worked. Women who grow up in poverty will probably live in poverty as adults and will probably need

some assistance.

At the same time, child care assistance grants are decreasing, and child poverty is on the rise.

What can you do? Urge that the Earned Income Tax Credit be raised from 6% to at least 10%. Gov. Snyder has indicated a willingness to do this as the Michigan economy improves. We should work for more funding for the Child Care Assistance program. She also suggested that the state drop the asset test for food assistance; it is unnecessary and the money comes from the federal government, not from the state coffers. Jacobs indicated that we get the most bang for the buck from childhood programs, and education funding should be increased.

CANDIDATE FORUM FRENZY

How do they do it? Jerry Burden, Ann Edwards, and Judy Bateman coordinated 24 Oakland County candidate forums covering races for U.S. Congress, State House, County Commissioners, Township, City and Village officials, Judges and School District boards. They could have done more if they could somehow have duplicated themselves!

In June and July, **Primary Election forums** were held for West Bloomfield Township and Southfield Township officials. A forum was held for County Commission District 18, State Rep District 40 in Birmingham, and State Rep District 35 in Southfield.

Judicial forums were held for the Primary Election for a Non-incumbent Circuit Court seat and three District Court races. For the General Election, forums were held for the Incumbent Circuit Court seats and two more District Court races. All of the forums were co-sponsored with the Oakland County Bar Association and the Free Press. Linda DePoorter and Jerry Burden moderated with Judy Bateman and Kath Maisner helping.

In September and October, **School District** forums held included: Birmingham, Bloomfield Hills, Huron Valley, and Ferndale. **Other forums** included: the 9th Congressional District, Milford Supervisor, Beverly Hills Village, Independence Township Trustees, Sylvan Lake City Council, and a Royal Oak Town Hall on city and school proposals.

Moderators were Tera Moon, Jerry Burden, Judy Bateman, Mary Howarth, and Linda DePoorter. Others helping were: Laura Gogola, Kath Maisner, Dorothy Conrad, Carole Elder, and Carol Beeman. All of these events were cablecast or available online.

Eva Packard was a panelist at the Council of Home Owners Association forum for US 14, State Rep 37, and County Commissioner 13, 14, & 21. LWV Northwest Wayne's US 11 and LWV Troy's MI 41 and County Comm. 11, 16, & 20 are also viewable.

The Rochester area was handled by Ann Edwards with State Rep 45th district forums for the Primary and General elections which were broadcast live and taped for cable. Carla Gribbs and Kristin Bull moderated with Karen DeGrendel, Mary Howarth, and Ann Edwards assisting.
