- Or at offices of Family Independence Agency, Dept. of Community Health, and Michigan Job Commission,
- Or at military recruitment centers.
- Also mail-in registration form up to 2 weeks before election
- Or register in person up to and including Election Day.

YOU MAY VOTE IF YOU ARE:

- a citizen of the United States, and
- 18 years of age by the date of election, and
- a resident of the community for 30 days, and
- can vote by absentee ballot for any reason.
- If register on election day, vote at your Clerk's office.
